This certified course offers a broad overview of global bond markets and fixed income analysis.

- standard measures of interest-rate risk and credit spreads, and how to apply them

- how bonds are issued and traded and the impact of regulatory and technological changes

Primary Market Certificate (PMC)

This qualification is recognised as the benchmark for professionals in the primary market. Covering the entire life cycle of bond issuance, it examines both the theoretical principles underpinning the markets and the instruments and financing techniques that are available.

- key characteristics and principles of syndication and origination functions
 -) factors that impact pricing decisions and launch requirements
 -) current liability management techniques, their applicability and outcomes
- the reasons behind events of default, debt ranking and covenants

The PMC is intended primarily for anyone in the origination, syndication and transaction management areas of investment banks or securities houses, but is valuable for capital markets lawyers or for anyone in institutions looking to raise funds in the international capital markets.

Debt Capital Market

Specialist courses

These non-assessed courses cover different topics within the primary markets at a more specialist level and count towards the ICMA Diploma in Debt Capital Markets, as well as organisational CPD requirements.

Bond Syndication Practices for Compliance and Middle Office Professionals

This short course aims to give compliance professionals an in-depth and thorough understanding of the practices that are involved in launching a deal in the international debt capital market, from first steps in the pre-launch process, up to and including the final public launch of the issue.

- the steps involved in syndication, including prelaunch processes, announcement to launch and allocation to pricing

Primary Market Financial Technology

Financial technology – or FinTech – is having an enormous impact on the financial services industry and nowhere is this more noticeable than in the changes taking place in DCM. This course is designed to provide participants with an accessible review of the role technology in the primary markets, both now and in the future.

 key concepts and themes for FinTech including digitization of book-building, new issue automation, digital assets, open source software, market data and more

Fixed Income Trading and Strategies

Specialist courses

Once debt securities have been created and issued on the primary market, they become tradable and investable assets. These specialist courses count towards the ICMA Diploma in Securities & Derivatives as well as organisational CPD requirements.

Fixed Income Portfolio Management & Construction

This course introduces tools and techniques for the management of fixed income portfolios, applying them first to analysing portfolios of real bonds and then to construction and management of portfolios.

On this course you will learn about:

drivers of performance of fixed income portfolios and how they affect investment outcomes

principles of portfolio construction vs benchmarks and vs liability benchmarks

 derivatives in portfolio construction – futures, swaps, swaptions, inflation swaps, single name and index CDS

The class is aimed at those with exposure to fixed income products who want better understanding of their application in a portfolio management context, including junior PMs, desk assistants, investment specialists, product managers, sales teams, researchers and economists.

Inflation-Linked Bonds and Derivatives

Credit Derivatives

Focusing mainly on single name and index default swaps this course considers the characteristics, valuation principles and applications of the credit derivatives product suite. The course includes index default options, first to default structures and 'tranched' investments.

-) the main features of single name and index default swaps.
- the principles of default swap valuation.
- credit correlation and how it impacts credit derivative structures such as basket structures and yieldenhanced tranched structures.

Understanding Swap Markets

Swaps are the most actively traded derivative product. This course covers those swap products with an interest rate component including interest rate swaps, overnight index swaps, asset swaps and currency swaps.

- valuation principles.
- trading and portfolio applications.
- managing swaps within a portfolio.

Fixed Income Options

Specialist courses

The trading and processing of securities and derivatives involves many participants from the financial services industry and covers a huge array of different functions. These courses look at different components of the product lifecycle and are all eligible to count towards the ICMA Diploma in Financial Market Operations as well as organisational CPD requirements.

Corporate Actions – An Introduction

Corporate actions arise on both equity and debt (bond) securities. Designed as an introduction to corporate actions, this course covers the fundamentals of this topic.

Even the most basic type of corporate action can prove a challenge from a processing perspective, requiring highly accurate event details combined with accurate (fully reconciled) internal books & records to be certain of controlled and risk-free processing.

Understanding the GMRA

This comprehensive workshop analyses how repo and securities lending transactions operate within the framework provided by the Global Master Repurchase Agreement (GMRA) - an essential underpinning of the cross-border repo and securities lending markets.

The transition to a sustainable global economy requires scaling up the financing of investments that provide environmental and social benefits. The bond markets through Green, Social and Sustainability Bonds as well as Sustainability-Linked Bonds can play an essential role in attracting private capital to finance these global needs.

ICMA serves as Secretariat of the Green Bond Principles (GBP), the Social Bond Principles (SBP), the Sustainability Bond Guidelines (SBG) and the Sustainability-Linked Bond Principles (SLBP) – principles that have become the leading framework globally for issuance of green, social and sustainability bonds.

ICMA Certificate in Sustainable Bonds

This course is designed for professionals who already have a reasonable understanding of fixed income but need to know more about the theory and real market application of sustainable bonds and all the ICMA principles (green, social, sustainability and sustainability-linked), coupled with the rapidly evolving global policy, taxonomies, and other relevant regulation. We will use practical examples and case studies throughout the course to enhance the learning. The course will be further enhanced with presentations from leading market participants – e.g., investors, external reviewers and issuers.

On this course you will learn to:

- identify and apply the key components of the ICMA Green Bond, Social Bond and Sustainability-Linked Bond Principles and the Sustainability Bond Guidelines, including their governance
- discuss the practical application of a Sustainable Bond/Finance Framework and the follow-on impact reporting from a sustainable bond
- discuss how the ICMA Climate Transition Finance Handbook works and how issuers can align with its guidance
-) recognise the different types of external reviews such as SPOs that can be assigned to sustainable bonds and frameworks

Is this course for me?

The qualification is intended for candidates who have at least basic grounding in the fixed income markets and some awareness of sustainable finance that are seeking an in depth understanding of the theory and practical application of sustainable bonds. Given the complete nature of the course it is well suited to investors, issuers, debt capital markets bankers, reviewers, researchers, lawyers and any others that touch this rapidly growing and key marketplace. appreciate the wider context of practicalities of the sustainable bond marketplace including the steps in coming to market, what investors are looking for and have come to expect, the role of indices, listing authorities and data providers, etc.
