BACKGROUND

The 10th Annual Conference of the Principles 2024

This year marks the 10th anniversary of the Green Bond Principles (GBP) which are the global voluntary standard for issuing bonds to fund environmental projects. Together with the Social Bond Principles (SBP), Sustainability Bond Guidelines and Sustainability-Linked Bond Principles (collectively known as "the Principles"), they have driven development of the global market for sustainable finance, underpinning a market representing near \$4 trillion of securities in stock, the largest source of debt capital finance available for sustainable projects and transition finance.

The Principles community, comprised of institutions from around the world including issuers, banks, NGOs and service providers in the market, meets annually to review market developments and socialise updates to the Principles.

The conference which will bring together market participants, observers, commentators, official authorities and media, attracted around 1,200 delegates, both in-person and virtual, last year in Singapore.

The roster of international speakers includes senior officials from national and international regulators, representatives from corporate, sovereign and supranational issuers of sustainable debt, banks and investors, with the participation of service providers eg exchanges, rating agencies, law firms and external reviewers.

The full day conference agenda will combine keynote speeches and panel discussions with leading market figures and experts in sustainable finance. It will feature key updates on the 2024 guidance from the Principles, as well as the critical topics being debated in sustainable finance from a global perspective including transition finance, market integrity and regulation.








